

EXAM PREP WORKSHOP - TECHNICAL FLORIDA IRRIGATION CONTRACTOR LICENSE

FIS is sponsoring an Exam Preparation Workshop for the required technical exam (not the city/county exam). This is one of the two exams needed to obtain a Florida Irrigation Contractor license. Join a class designed for irrigation contractors who may have similar concerns and questions in preparing for the exam.

TOPICS COVERED IN WORKSHOP: General review of content areas on the irrigation exam, differences between the counties and Florida exam, test-taking strategies, simplified method to perform math calculations, how to tab books for easy reference during exam, best use of time during exam, practice exams.

OPTIONAL: The Irrigation Technical exam is an open book exam. Books allowed by the State to be used during the test session: CFR Title 29, Part 1926 OSHA, 2013; Irrigation 6th Edition 2011; Florida Building Code: Plumbing, 2010; White Rite-on-tabs (10 sheets) Reuse of Reclaimed Water 62-610; FL Statutes FPR State Irrigation Exam, Simplified Irrigation Design 1995, by Pete Melby (for class only). Books may be purchased at an FIS discounted price of \$452.43 plus shipping.
