FEE COVERS: Live instruction by experienced exam prep instructor who has passed the license exam and study guides. Books are not included in fee. **NO PASS GUARANTEE:** If attendee fails the exam, he/she may retake the workshop at no cost within 12 months of the exam.

BOOKS: The Irrigation Contractor licensing exam is an open book exam. Books allowed as reference during the State Exam must in-hand for use during the session(s). Contact the Florida Irrigation Society to get exam book ordering information.

TOPICS COVERED IN WORKSHOPS: **Business and Finance:** Establishing the contracting business, managing administrative duties, managing trade operations, conducting accounting functions, managing human resources, and complying with government regulations. **Technical:** General review of content areas on the irrigation exam, and Florida exam, test-taking strategies, simplified method to perform math calculations, how to tab books for easy reference during exam, best use of time during exam, practice exams.
