

EXAM PREP WORKSHOPS - BUSINESS / FINANCE AND TECHNICAL
FLORIDA IRRIGATION CONTRACTOR LICENSE WEBINARS

Join the Florida Irrigation Society for a virtual exam preparation workshops for the required exams needed to obtain a Florida Irrigation State Contractor license. This format will allow those in remote areas or with limited travel time to participate in the Society's classes designed specifically for irrigation contractors.

2024 WEBINAR DATES: Each webinar is from 4:00pm-8:00pm

3-Day Business and Finance: (\$550 /person) February 13-15; April 9-11; June 11-13; August 13-15; October 8-10; December 10-12

2-Day Technical: (\$495/person) January 16-17; March 12-13; May 14-15; July 9-10; September 10-11; November 12-13

Sessions are recorded so attendees can access them after the instruction period has ended. The workshops are 100% virtual – no need to travel! Registered attendees will be given a link to the webinars and instructions on how to participate. An in-person Technical workshop will be held at the 2024 Water Summit, date and location TBA.

FEE COVERS: Live instruction by experienced exam prep instructor who has taken the license exam. Books are not included in fee.

NO PASS GUARANTEE: If attendee fails the exam, he/she may retake the workshop at no cost within 12 months of the exam.

BOOKS: The Irrigation Contractor licensing exam is an open book exam. Books allowed as reference during the State Exam should be in-hand for use during the session(s). Contact the Florida Irrigation Society to get exam book ordering information.

TOPICS COVERED: Business and Finance (3-days): Establishing the contracting business; managing administrative duties; managing trade operations; conducting accounting functions; managing human resources; and complying with government regulations. Technical (2-days): General review of content areas on the irrigation exam, and Florida exam, test-taking strategies, simplified method to perform math calculations, how to tab books for easy reference during exam, best use of time during exam, practice exams.
